### **EMBALMING**

If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.I.A.C. 8:9-1.1)
