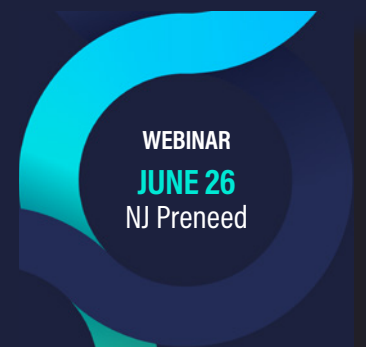

COURSE DESCRIPTIONS

FUNERAL DIRECTING ETHICS (ETHICS)

Revealing Your Ethical Funeral Service Orientation

Participate in an engaging and practical exploration that uncovers your ethical orientation. This session will guide funeral directors in establishing ethical work practices to prevent questionable actions or wrongdoing. Commencing with a review of the fundamentals of ethics, participants will actively participate in a dynamic debate centered around contemporary case studies. This interactive approach aims to enhance ethical decision-making skills in the day-to-day practice of funeral directing, fostering a greater understanding of ethical principles and their application in the profession.

NEW JERSEY LAW AND RULES (LAW)

Work First New Jersey and Indigent Funerals

Uncover the legal aspects of providing funeral services for the less fortunate in New Jersey. This session will clarify what is included or permitted in an indigent funeral, ensuring reimbursement from the State of New Jersey and the 21 counties. Learn about the right to control, available reimbursement rates, family supplementation, and potential irregularities that may arise when arranging services for Work First New Jersey recipients, indigents, unclaimed cases, and unidentified decedents.

AG's Directive on Discrimination and Harassment

Gain insights into the Administrative Executive Directive issued by the Attorney General which has a significant impact on professional boards and licensees overseen by NJ's Division of Consumer Affairs. Delve into the regulations surrounding "professional misconduct" specifically addressing discrimination, harassment, and retaliatory conduct. Understand the importance of dealing with these issues to maintain operational integrity in the funeral home. This presentation explores conflict and addresses the impact of workplace culture on employee retention and satisfaction. From miscommunication to bullying, workplace tension can be challenging. Learn effective communication strategies to address conflicts, build trust, and cultivate a healthy, inclusive culture in the workplace as well as comply with these new Mortuary Board regulations.

FEDERALLY MANDATED OSHA FUNERAL HOME TRAINING (OSHA)

Full- and part-time as well as per diem funeral home employees, interns, compliance officers and anyone who enters a prep room are required to receive training in OSHA.

Full-time, part-time and per diem funeral home employees, compliance officers and anyone who maintains a written OSHA compliance plan, enters a prep room, or is present where chemicals are stored or used will benefit from this educational opportunity in OSHA compliance essentials.
