2019 CONTINUING EDUCATION PROGRAMMING

ETHICS (1 CEU)

Ethical Dilemmas in Funeral Service

This course addresses the complexities of ethical decision making in the funeral profession. A practical discussion of business ethics will be conducted using specific examples of the funeral industry. Attendees will hear ways that funeral directors can establish ethical work practices that may reduce the possibility of questionable funeral home practices or wrongdoing.

LAW (2 CEUs)

Responding to Complaints and a Review of Professional Misconduct

This seminar will review the role of the State Board of Mortuary Science of New Jersey (Mortuary Board) and the laws governing its licensing, investigative and enforcement powers as well as the Mortuary Board's procedure for receiving and processing complaints against licensees and mortuaries.

2019 Updates to Mortuary Board Regulations

In this seminar, attendees will review the proposed changes and updates to funeral service regulations promulgated by the State Board of Mortuary Science of New Jersey. Proposed changes to the Statement of Funeral Goods and Services Selected; preneed notification and recordkeeping requirements; intern application and preceptor requirements; and license reinstatement procedures will be reviewed.

OSHA (2 CEUs)

OSHA Paperwork Obligations

This seminar will cover Occupational Safety and Health Administration (OSHA) regulations as they relate to funeral service personnel with oversight responsibility. The necessity of maintaining a written communication plan and the associated forms, documents, releases and ancillary paperwork will be detailed along with retention requirements.

Preventing Back Injuries in Funeral Service

This course reviews various safe work practices funeral home employees should take to prevent back and spinal injuries while carrying out the necessary duties of funeral service such as removals and transferring human remains; embalming, dressing and casketing; and receiving and stocking supplies.

PRENEED (2 CEUs)

Making Preneed Funeral Arrangements: Consumer Considerations

Attendees will review the factors that contribute to a consumer's decision to make preneed funeral arrangements and how funeral directors can assist consumers to increase their understanding of the purpose of preneed arrangements, how to make such arrangements, and the rights and protections afforded to them by law.

Choosing a Preneed Funding Vehicle: Consumer Conversations

This course is designed to guide the funeral director in his or her conversation with the consumer on how to select a preneed funding vehicle. Using interactive scenarios, attendees will engage in discussion on the types of preneed funding options available to consumers and will be able to educate consumers on how to make their selection based on their financial needs and prefunding goals.
